Practical experience in regional integration and economic cooperation, and at least one of the above mentioned areas that was gained through involvement in macroeconomic policy analysis, international trade policy formulation and negotiations, infrastructure development policies as well as implementation of programs, research, teaching or related work. Record of relevant publications would be an asset. Adequate knowledge and exposure to IGAD and regional economic cooperation initiatives will be required.
