Promoting live animal and meat export from IGAD Region

The Horn of Africa (HoA) Region currently exports over 50% of live animals, and less than 10% of the annual demand in the Middle East and North African (MENA) countries, despite being in close proximity to importing countries in addition to importers having a particular preference for livestock from the HoA countries. The limited livestock and meat products export to those countries is partly due to poor vertical and horizontal linkage between the main actors and regulatory institutions at both ends: HoA and MENA countries. As such, exporters have continued with their traditional way of marketing with little awareness or promotion materials on their products to increase export trade. This has led to the Horn of Africa countries losing some share of live animal and meat trade to the Gulf countries due to limited effort in meeting the sanitary requirements and hygiene certification that are technical hindrance to trade. Moreover, there is an information gap between traders and importers when it comes to real time market information and dissemination of this information on import requirements as well as commodity prices and promotional efforts. Below is a summary of import requirements disaggregated into general and country requirements.

Sanitary and phytosanitary import requirements of MENA countries

GENERAL

Live animals

Quarantine for 21-30 days & be free from transboundary animal diseases (TADs) and any other diseases.

Originate from an internationally known port, have bill of lading etc



Meat

Slaughter animals that are free from transboundary animal diseases (TADs).

Accompanied by an original health certificate issued by competent veterinary authority indicating date of slaughter. expiry and shelf life.

Accompanied by certificate of origin & Halal slaughter certificate.

Hazard Analysis and Critical Control Point system (HACCP) applied at all production phases at the abattoirs and factories approved by importing countries.
