# Development of National Livestock Identification and Traceability System (LITS) Strategy for Somalia

#### **Background**

Livestock production has been the backbone of the Somali economy for many centuries. It is the most important source of food and income for the predominantly rural population, as well as the country's biggest export commodity. It is the major source of household wealth and supply end products that include milk, meat and hides and skins and transport. Prior to the war, some 46% of the total population were engaged in nomadic pastoralism and livestock accounted for 40% of the GDP and 80% of all export earnings. The use of production based approach to estimate the contribution of livestock to economy of Somalia yielded an estimate of 8.157 Billion USD in 2013. This estimate is above the IMF estimate of Agriculture GDP of 5.7 Billion USD where livestock contributes 2.28 Billion USD, equivalent of 40% of Agriculture contribution to GDP¹. The export trade is often affected by outbreaks of some transboundary animal diseases that lead to trade bans or halts by major importing countries in Middle East and North Africa (MENA) countries especially Kingdom of Saudi Arabia (KSA), the dominant importer.

For adequate traceability of livestock and their products by importers, application of livestock identification and traceability system (LITS) is becoming a key requirement. LITS is becoming a pre-requisite for exporting countries to implement in order to access and expand export markets since it is an effective means to successfully protect public health, food safety and contain or respond to an outbreak of an infectious animal disease. The system requires two basic components: an identification system (for example brands, marks or a device) and a system that tracks an animal, or group of animals, along the value chain to the final destination. It is only when these components are all put together that LITS becomes functional. LITs can also help in curbing cattle rustling; recently Camel rustling also reported in Somalia.

IGAD Center for Pastoral Areas and Livestock Development (ICPALD) trained national LITS focal personnel and other team members, developed regional guidelines and legal framework that guide in the implementation of LITS in the member States including Somalia through its subsequent adaption to national laws. For Somalia to sustain export of livestock and livestock products, it is important for the country to develop a national strategy in LITS and do a coordinated efforts to implement it. This is because most international market outlets for livestock and livestock

products are increasingly demanding that animal health status are known and traced properly. Moreover, development of the strategy will help in coordination of stakeholders, contribute to resource mobilization efforts among others to roll out the system. ICPALD is seeking to support the Federal Government of Somalia to develop a national strategy on LITS by contracting an experienced consultant in matters of LITs. The successful incumbent will develop a national LITS strategy and facilitate its validation.

#### Objective of the assignment

To develop and validate a LITs strategy for the Federal Republic of Somalia

## Specific tasks

- Draft an inception report detailing clear understanding of the assignment including tentative timeline and deliverable including an outline of the strategy
- Undertake desk review of available and success livestock identification and traceability systems around the globe, continent, IGAD region
- Review performance of pilot studies undertaken in Kenya and Ethiopia in terms of achievements realized, challenges faced and applicable solutions,
- Carry out country situation analysis of LIT systems covering the producers, traders; export
  quarantine stations /exporters, identify key gaps and how they can be addressed as well as
  good practices and lessons to form part of the strategy
- Draft the national strategy
- Facilitate validation of the strategy
- Produce a final report

- Inception report
- Strategy validation workshop report
- Validated national strategy on LITS for Somalia

# **Consultancy location and office accommodation**

The assignment will be home-based with visit to necessary offices for data and information collection, meeting and stakeholder consultation. The consultant will use his/her own computer, photocopying, telephone and Internet facilities and other necessary equipment for the assignment.
