Consultant to Facilitate a Public Forum to Share Lessons on Impact of Harmonized Standards in Staple Grain in Cross-Border Areas of Karamoja and Mandera Clusters

1.0 Introduction

The IGAD Drought Disaster Resilience and Sustainability Initiative (IDDRSI) Implementation Letter (IL) project, funded by USAID and implemented by IGAD has been designed to build resilient communities through strengthening market systems in the IGAD region, particularly of clusters 1 and 3 i.e. Karamoja (Uganda-Ethiopia-Kenya-South Sudan) and Mandera (Kenya-Somalia-Ethiopia) respectively. The market systems in these cross-border areas are affected by several factors including weather and climate vagaries and associated environmental pressures; conflict and political instabilities; irregular and unpredictable food flows and volatility in food prices; poor information flow between policy makers, enforcers and traders as well as *ad-hoc* trade restrictions due to non-tariff barriers related to standards and policies among others. The challenges discourage sustained private sector investment, reduce the ability of the market systems to cope with added shocks and stresses, and consequently, reduces their effectiveness in sustaining cross-border communities in case of drought-induced disasters that the project is designed to address.

In Karamoja and Mandera Clusters, production of the African staple grain and horticultural value chains is characterized by smallholder farmers, who form 60-80 percent of the farming constituency. Maize, sorghum, and teff, sesame, sunflower, sugarcane, mangoes, oranges are the main food and cash crops that are produced in the two clusters.

To promote cross-border trade, it is important to create awareness of cross-border trade regulations and procedures such as the Common Market for East and Southern Africa (COMESA), Simplified Trading Regime (STR) and the East African Community (EAC) harmonized grain standards as well as cross-border trade procedures and documentation needed to clear goods; barriers to access to working capital and other financing needed to grow businesses.

To build on achievements of years 1 and 2 of 'Building Resilient Market Systems in the Crossborder Drylands of the IGAD Region' Implementation Letter Project funded by USAID, ICPALD is planning to convene one public forum to share with the beneficiary communities lessons learnt on impact of harmonized standards in staple grain on crossborder trade. The incumbent consultant will develop materials on lessons from impact of harmonized standards in staple grain crossborder trade and facilitated two-day workshop with selected beneficiaries from the two clusters.

- i. Draft and submit scope of work report showing understanding of the assignment including work plan and clear milestones of how the assignment will be delivered and outline of the workshop materials
- ii. Consult East African grain council and cross border traders; document details on the harmonized standards in staple grain; impacts observed and lessons
- iii. Share feedback on Mutual recognition and equivalence agreements as alternatives to harmonization
- iv. Develop workshop materials on lessons from impact of harmonized standards in staple grain trade in crossborder areas
