IGAD Centre for Pastoral Areas and Livestock Development (ICPALD) has received funding from the Swedish International Development Agency (SIDA) on Sustainable Ecosystem Management (SEM) for pastoralism in cross-border areas of the IGAD region. The project is being implemented in the crossborder areas of Kapoeta East County (South Sudan)- Kaabong District (Uganda) and Benishangul-Gumuz Region (Ethiopia)- Blue Nile State (Sudan) which correspond to the shared ecosystem and transhumance routes.

It is intended that part of the proceeds of this financing will be applied to eligible payments under the contracts for *Construction works in Ethiopia, Uganda and South Sudan*.
